PURPOSE: The purpose of this tournament is for JV Wrestlers not Varsity Wrestlers. Wrestlers that enter should **not** be potential entries for District XI Championships.

SEEDING: To be eligible a wrestler:

-- cannot have more than six (6) varsity wins

-- varsity forfeits do no count as wins

-- must have at least ten (10) JV matches to be seeded -- varsity wins may be counted as JV wins with record (losses will not count)

subtract 10 points for each bout under 10 from the total percentage

Record winning percentage will determine seed.

Examples:

Varsity 5 - 4

JV Record 6 - 1

Over-All Record 11 - 1 Seeding Point - 91.67

Varsity 1 - 4

JV Record 4 - 7

Over-All Record 5 - 7 Seeding Point - 41.67

RULES:

- PIAA Rules will apply
- four (4) mats will be used
- match times 2-2-2
- consolations 2-1-1

TABLE WORKERS: All teams must provide table help for at least two hours! - All teams must help put mats away.

THERE WILL BE NO SEEDING MEETING:

ALL ENTRIES MUST BE FAXED OR E-MAILED BY FEB 12
Wrestlers will be seeded by percentage record and points.

No changes will be accepted the day of the tournament – All entries must be in – No changing weights the day of the tournament – No New Entries!
